PRESIDENT'S MESSAGE – August 2005

On July 27, 2005, the Metropolitan Transportation Commission adopted a groundbreaking Transit Oriented Development Policy that requires areas around new transit stations to meet certain development thresholds if the transit improvements are to be funded. This was a result of many years of effort by the LWVBA and other organizations that encouraged MTC to take land use considerations into their transportation planning and funding. MTC will actually be funding the development of specific land use plans in eight station areas.

UPDATE FROM LWV BAY AREA

The next phase of this TOD effort will focus the development of Specific Plans in the following transit extension corridors:

Ferry Terminal at Alameda Point, e-BART corridor in Contra Costa County, Capital Corridor at Fairfield Multi-Modal Station, Dumbarton Rail Station in Menlo Park, T-BART at Hacienda in Pleasanton, Bus Rapid Transit in downtown San Leandro BRT Station, Sonoma-Marin Area Rail Transit in Downtown Santa Rosa, BART to San Jose Santa Clara Station.

LWVBA would like each of the local Leagues in which these plans are being developed to become informed and involved in the process locally to assure that the appropriate level of transit oriented development (i.e. infill density, affordable housing, mixed uses, etc.) is approved by your cities. We will support and work with you in this effort.
